**Down Payment**

- A \$200 down payment is due upon reservation to reserve your stay. The individual (Coordinator) who signs the Rental Agreement is responsible for any reservation changes, and for paying the down payment.
- An email confirmation will be sent to confirm your reservation. Your group will have the first chance at reserving the same weekend for the following year. This decision must be made before departure.

**Payment Information:**

- Full Payment is due within 30 days prior to your stay. If Payment is not made within 30 days, your reservation will be cancelled, and down payment will be forfeited. The coordinator will pay with one form of payment for their group. \*\*We accept personal check, cash, or credit card \*\*Checks payable to **Circle F Farmhouse LLC**
